Instructions for Presentations to the Board by Parents and Citizens

Method Schools ("School") welcomes your participation at the School's Board meetings. When addressing the Board, speakers are requested to state their name and address and adhere to the time limits set forth.

Public Communication on Non-Agenda Issues: This is an opportunity for members of the audience to raise issues that are not specifically on the agenda. You will be given an opportunity to speak for a maximum of three (3) minutes and total time allotted to non-agenda items will not exceed fifteen (15) minutes. Non-English speakers requiring translation are allotted a maximum of six (6) minutes. Due to public meeting laws, the Board can only listen to your issue and not respond or take action. The Board may give direction to staff to respond to your concern or you may be offered the option of returning with a citizen-requested item

Agenda items: To address the Board on agenda items, please specify the item on which you wish to speak on your "Public Comment". You will be given an opportunity to speak for up to three (3) minutes when the Board discusses that item.

3. Public Records: Any public records relating to an agenda item for an open session of the Board that are distributed to the Board members shall be available for public inspection at the School office. Minutes of each Board meeting will also be available at the School office.

 - EOY Update
 - Jessica Spallino: We're finishing up our oversight process with Dehesa and Acton. We'll be hearing more from them in August. We'll have new OKRs to share and end of year data at the next meeting.
- CBO:

Marketing Update

- Mark Holley: We focus on the product and making it referrable. Students aren't assigned to us. We get a lot of website traffic. We've gotten back up to the biggest numbers we've had, with the exception of COVID year.
- Question: Shannon Clark: What's our split of ADA between K-8 vs. high school?
- Jade Fernandez: Half of our students are in K-8 and the other half are high school.
- Mark Holley: The website for the Dehesa Method Sports Academy (DMSA) is up and it will hopefully attract students.
- Question: Steven Dorsey: What's the focus?
- Mark Holley: We'd like to do a little bit of extreme sports, and a lot of the middle school travel ball.
- Question: Shannon Clark: Have you looked at any partnerships with BMX?
- Mark Holley: We do get some BMX students. It's not a huge market.
- Shannon Clark: How do we plan to balance the cases where parents want their kids to fail so they can be held back?
- Jessica Spallino: We've got a policy in place, we've lost a lot of good student athletes because we won't retain them. They go through a process and ultimately it comes to you, the board.
- Question: Steven Dorsey: Is the expectation that the kids will go to the DMSA campus?
- Mark Holley: Yes. DMSA is for students who want to be on campus and do the academic and athletic training Monday Thursday. Student athletes have always been our biggest growth area.

- Jade Fernandez: 1) Appropriately Assigned Teachers, Access to Curriculum-Aligned Instructional Materials, and Safe, Clean and Functional Schools Facilities - we have nothing to report here, we are all good in this area.
- Sarah Delawder: 2) Implementation of State Academic Standards for supporting the staff in being able to understand the standards that are being implemented, we're doing professional development with staff, and across the board we are NGSS compliant.
- Jade Fernandez: 3) Parental Involvement and Family Engagement This local indicator has to do with how much we're involving parents and engaging families. We're doing well. We expanded our PAC membership from 2 to 4, and a huge increase in attendance in school activities and field trips. We're going to make sure we're supporting everyone in their transition to CBL (Competency Based Learning). 4) School Climate- we do really well with making sure our staff is supported. 94% of parents are extremely satisfied. 5) Access to a Broad Course of Study- we're expanding our course catalog, technology resources are getting better, and accessibility tools.
- Question: Shannon Clark: Do we have any numbers of how many graduating seniors are college-bound?
- Jade Fernandez: I can get that for you.

 - Jade Fernandez: We're done with our CASSP window, we hit 95% participation. Prom was May the 4th, we had a field day, and had graduation.

 - Sarah Delawder: We're using the philosophy of skills based learning as a framework. Our objectives are not only to improve academics but attendance. Teachers are working on mastery and feedback. Our goal is to create an equitable learning environment. We can make our own instructional content and embed it within SmartFox.

Discussion: Stefanie Bryant: The governor had an 8.0% COLA for LCFF this year. It is probably going to slow down. We are estimating about 1,050 ADA. Expenditure Assumptions- there are not a lot of changes there. We're proposing an 8.0% COLA on salaries to stay competitive. We've also included budgets for the new Dehesa Method Sports Academy. For the current fiscal year, we started at 1000 ADA, and we're at about

835 ADA. Expenditures- the most is spent on salary and benefits.
