All of the attendance reported is for pupils whose attendance is eligible for public funding pursuant to Education Code section 47602(b).

Charter schools are required to operate a minimum of 175 days of actual instruction between July 1 and June 30 of each school year to receive a full apportionment. Charter schools not fulfilling this requirement will have their apportionment reduced proportionally [5CCR, §11960(b)] and be assessed a penalty. A charter school must offer the state minimum required number of annual minutes (as defined in Education Code section 46201). The charter can submit a waiver to the State Board of Education for the penalty associated with offering too few instruction days. If applying for the waiver, the LEA must add the number of days missed to their school calendar for two years. I hereby certify that our district met the instructional time goals, along with all other requirements of Education Code Section 46201 et seq.

Subsection 432(F)(2) defines "Mandatory Permanent Pupil Records" to include an annual verification of the name and address of the parent and residence of the pupil.
